- iv. *He shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned additional Director General of Police (CID) J&K the appointee shall have no right to claim his/her appointment as teacher and his/her appointment as such shall be deemed to have been cancelled.*
- v. *The appointee shall furnish an affidavit to the effect that in case the documents submitted by him/her found to be fake or fictitious, the appointment shall be deemed to have cancelled in abintio and the department shall initiate legal proceedings against him/her.*
- vi. *The appointee if adjusted against SSA vacancy shall not be allowed to join.*
